1. I wish to serve as an unpaid volunteer for Barrens Soccer Club, Inc. (“Barrens”).
  
2. I am submitting this Affidavit to Barrens in accordance with the provisions of Section 6344.2(B.1) of the Pennsylvania Child Protective Services Law, 23 Pa.C.S.A. Section 6301 et seq.
  
3. I understand that Barrens will be relying on my statements in this Affidavit for the purpose of determining whether I may serve as an unpaid volunteer for Barrens.
  
4. I have been a Pennsylvania resident during the entirety of the ten-year period immediately preceding today’s date.
  
5. I am not disqualified from service as a volunteer pursuant to Section 6344(C) of the Pennsylvania Child Protective Services Law, in that:

- a.xiv. **Section 4303 (relating to concealing death of child);**
- a.xv. **Section 4304 (relating to endangering welfare of children);**
- a.xvi. **Section 4305 (relating to dealing in infant children);**
- a.xvii. **A felony offense under section 5902(b) (relating to prostitution and related offenses);**
